INTRODUCTION

The European Parliament is currently actively involved in the negotiations on the different asylum instruments. As clearly stated in the Stockholm Programme, the establishment of a common area of protection and solidarity, based on a common asylum procedure and a uniform status for those granted protection remains one of the prime objectives of the EU in the coming years.

The Common European Asylum System (CEAS) with common rules and a better and more coherent application of such rules should contribute to an increased mutual trust between Member States. Europe will need a flexible asylum policy which is responsive to the priorities and needs of Member States. People in need of protection must be ensured access to legally safe and efficient asylum procedures. The development of the CEAS should be based on a full and inclusive application of the Geneva Convention on the status of refugees and other relevant international treaties.

The European Parliament (by means of the Policy Department C, on citizens' rights and constitutional affairs) requested in 2008, a study to the Odysseus network (the Academic Network for legal studies on immigration and asylum in Europe) "Setting up of a Common European Asylum System - on the application of existing instruments and proposals for the new system". This study is expected to be finished at the end of May 2010. As different asylum instruments are at present discussed in parallel it would, at this stage, be essential to debate the horizontal issues.
